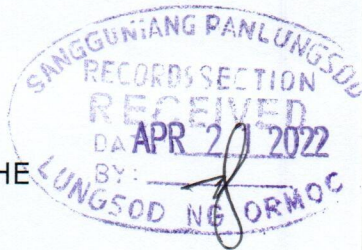

WHEREAS, the 15th Sangguniang Panlungsod ng Ormoc City received an endorsement dated April 5, 2022 from the City Mayor Richard L. Gomez relative to SP Resolution No. 2021-188, Series of 2021 which entitles: "A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD L. GOMEZ TO IDENTIFY AND IMPLEMENT PROGRAM ITEMS WHICH ARE APPROPRIATED IN GENERIC TERMS UNDER THE 2022 ANNUAL INVESTMENT PROGRAM (AIP) PROVIDED, THAT A LIST OF IDENTIFIED AND PROGRAMMED INFRASTRUCTURE PROJECTS APPROPRIATED IN GENERIC TERMS FOR A PARTICULAR MONTH BE SUBMITTED TO THE SANGGUNIAN PANLUNGSOD ON OR BEFORE THE 15TH DAY OF THE SUCCEEDING MONTH;

WHEREAS, under CDC Resolution No. 2021-02, Series of 2021, the Ormoc City Development Council has passed and approved the aforesaid resolution to promote effective, efficient and economical governance which will redound to the general welfare of the Ormoc City constituents;

WHEREAS, the granting of authority for the City Mayor to identify and implement program items which are appropriated in generic terms (AIP 2022) is subject to the condition prescribed that a list of identified and programmed infrastructure projects appropriated in generic terms for a particular month be submitted to the plenary on or before the 15th day of the succeeding month;

WHEREAS, the august Body considers the request of the Ormoc City Development Council to be substantial and reasonable and is deemed more practical and convenient to the city government in order to fast track the implementation of the priority infrastructure projects of the city which are deemed responsive to the present needs and envisioned to propel local economic growth and development. Hence, the matter is most deserving of prompt and favorable consideration;
