WHEREAS, this Sanggunian has received a communication dated March 25, 2022 from the Honorable City Mayor Richard I. Gomez requesting for the passage of a resolution in reconstituting the People's Law Enforcement Board (PLEB) membership;

WHEREAS, Section 43 of Republic Act No. 6975 mandates for the establishment of the People's Law Enforcement Board (PLEB) by Sangguniang Panlungsod/Bayan in every city and municipality;

WHEREAS, pursuant to above-mentioned Republic Act, the City Government of Ormoc previously availed for the creation of the People's Law Enforcement Board (PLEB) by passing Resolution No. 39, which task is to receive and decide citizens' complaints against erring officers and members of the Philippine National Police (PNP) within the jurisdiction of Ormoc City;

WHEREAS, Rule 11, Section 4 of the Memorandum Circular No. 2007-001 (Uniform Rules of Procedure Before the Administrative Disciplinary Authorities and the Internal Affairs Service of the Philippine National Police) states that, "The Sangguniang Panlungsod shall pass a resolution formally organizing the members of the People's Law Enforcement Board (PLEB), a copy thereof shall immediately be submitted to the City Mayor who shall, within five (5) days from receipt of the same, issue the appropriate Executive Order adopting the Resolution of the Sanggunian concerned. A copy of said Executive Order shall be furnished to the NAPOLCOM Regional Office within ten (10) days from issuance.";

WHEREAS, previous member Atty. Maria Alyssa Rodriguez is deemed *ipso* facto resigned from People's Law Enforcement Board (PLEB) due to her being a government employee as an Associate Lawyer III (Officer In-charge - Assistant City Legal Officer) of the Local Government of Unit of Ormoc;

WHEREAS, there is now a need to reconstitute the People's Law Enforcement Board (PLEB) of Ormoc by passing another Resolution appointing a new member to replace Atty. Maria Alyssa Rodriguez;

WHEREAS, Section 43, par. (b) (3) of RA 6975, provides for the Composition of the PLEB as follow:

Three (3) other members who shall be chosen by the peace and order council from among the respected members of the community known for their probity and integrity, one (1) of whom must be a member of the Bar or, in the absence thereof, a college graduate, or the principal of the central elementary school in the locality.

WHEREAS, after due deliberation by the Joint Committee on Justice and Peace and Order and Committee on Good Government and Oversight, it identified and officially endorsed Atty. Chelissa Mae Rojas, CPA as member of the People's Law Enforcement Board (PLEB) of Ormoc;

WHEREFORE, foregoing premises considered, on motion of SP Member Jasper M. Lucero, Chairman, Committee on Good Government & Oversight severally seconded by SP Members Tomas R. Serafica, Roiland H. Villasencio, Peter M. Rodriguez, Lalaine A. Marcos, Esteban V. Laurente and Joan Marbie C. Simbajon; be it
