RESOLUTION NO. 2022-109

A RESOLUTION INTERPOSING NO OBJECTION TO THE WATER PERMIT APPLICATION OF CEBU LANDMASTERS INC. - CASA MIRA HOMES ORMOC - CASA MIRA HOMES OURCES OF THE DEPARTMENT OF ENVIRONMENT AND NATIONAL RESOURCES (DENR)

WHEREAS, the Local Government Code (R.A. 7160) mandates for every Local Government Unit to exercise its inherent powers, as well as share with the national government the responsibility in the management and maintenance of ecological balance in its respective territorial jurisdiction;

WHEREAS, the City Government of Ormoc adheres to the mission to protect, in all ways possible, the environment and the Ormocanon people;

WHEREAS, during the SP Regular Session last March 29, 2022, the Sangguniang Panlungsod ng Ormoc endorsed to the Chairperson of the Committee on Environment, Natural Resources and Energy Conservation, SP Member Lalaine A. Marcos a copy of the Water Permit Application of Cebu Landmasters Inc. – Casa Mira Homes Ormoc DW1, with the National Water Resources Board (NWRB) of the Department of Environment and Natural Resources (DENR);

WHEREAS, during the April 4, 2022 committee meeting of the Committee on Environment, Natural Resources and Energy Conservation, the Committee found out through the manifestation of Cebu Landmasters Inc. that the project which the water permit application is necessary covers ten and a half (10.5) hectares, consisting of Six Hundred and Eighty-Five (685) units of housing;



WHEREAS, SP Member Lalaine A. Marcos reminded Cebu Landmasters Inc. to submit to and comply with the requirements stipulated in Ordinance No. 149, Series of 2008 and Ordinance No. 077, Series of 2021 in order to prevent any circumvention of locally enacted laws geared for the assurance of the good quality of water and other lawful regulations and requirements;

WHEREAS, Section IV of Ord. No. 149 s. 2008 stipulates:

 A. Any person, whether natural or juridical, who intends to extract or mine water from within the jurisdiction of Ormoc City for industrial, commercial or institutional use, is required to register with the City Waterworks Office, for monitoring purposes and in accordance with Tax Ordinance No. 96-01 xxx

- B. The extractor/proponent shall be required to submit a monthly report of the true volume of extraction of the preceding month, to be submitted within the first ten (10) days of the month immediately succeeding.
- C. Extractor/proponent shall be required to install prior to its operation, a device to measure the volume/quantity of the water extracted.

All water supply projects are required to secure an Environmental Compliance Certificate (ECC) except Level II/Level I/water refilling station.

If the work on the individual water supply system failed to commence within six (6) months from date of issuance, the site clearance shall automatically expire;

WHEREAS, this Sanggunian thereby interposes no objection to the Cebu Landmasters Inc. - Casa Mira Homes Ormoc - DW1's Water Permit Application provided the same is in accordance and obedience to Ord. No. 149 s. 2008 and Ord. No. 077-2021.

WHEREFORE, on motion of SP Member Lalaine A. Marcos, Chairperson, Committee on Environment, Natural Resources and Energy Conservation, severally seconded by SP Members Roiland H. Villasencio, Tomas R. Serafica, Vincent L. Rama, Gregorio G. Yrastorza III, Esteban V. Laurente, Joan Marbie C. Simbajon and Jasper M. Lucero; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION INTERPOSING NO OBJECTION TO THE WATER PERMIT APPLICATION OF CEBU LANDMASTERS INC. – CASA MIRA HOMES ORMOC - DW1 WITH THE NATIONAL WATER RESOURCES BOARD (NWRB) OF THE DEPARTMENT OF ENVIRONMENT AND NATIONAL RESOURCES (DENR);
