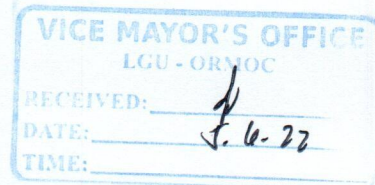

WHEREAS, the Local Finance Committee, this city, has submitted to this august Body for review action the Sangguniang Kabataan Annual Budgets for CY 2022 of the aforementioned Barangays, this city;

WHEREAS, based on the initial review of said budgets conducted by the Local Finance Committee and Finance Committee of the Sangguniang Panlungsod, it has been found out that said budgets have shown substantial compliance with budgetary guidelines and other budgetary issuances;
