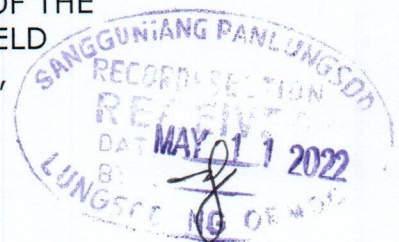

GOMEZ OR HIS REPRESENTATIVE THE AUTHORITY TO ENTER INTO AND SIGN A MEMORANDUM OF COMMITMENT (MOC) FOR THE PROJECT ENTITLED: "SUPPORT TO THE IMPLEMENTATION OF THE REGIONAL COLLABORATIVE PROGRAM FOR AGRICULTURE, AQUATIC AND NATURAL RESOURCES RESEARCH AND DEVELOPMENT IN REGION 8" OF THE VISAYAS CONSORTIUM FOR AGRICULTURE, AQUATIC AND NATURAL RESOURCES PROGRAM

WHEREAS, the 15TH Sangguniang Panlungsod ng Ormoc received an endorsement letter from the Office of the City Mayor on April 21, 2022 for consideration of a Memorandum of Commitment (MOC) for the project entitled: "Support to the Implementation of the Regional Collaborative Program for Agriculture, Aquatic And Natural Resources Research and Development in Region 8" of the Visayas Consortium For Agriculture, Aquatic and Natural Resources Program, a copy of the MOC is hereto attached as "ANNEX A" and made an integral part hereof;

WHEREAS, the Visayas Consortium for Agriculture, Aquatic and Natural Resources Program (ViCARP) is a consortium of agencies and institutions undertaking research and development in agriculture and natural resources in Eastern Visayas;

WHEREAS, ViCARP has entered into a Memorandum of Agreement with the Philippine Council for Agriculture, Aquatic and Natural Resources Research and Development (PCAARRD) for the aforementioned project under the MOC;

WHEREAS, the purpose of the consortium is exclusively for the promotion of science, technology and innovation applications in Region 8 for agriculture, aquatic, and natural resources sector through:

1. Strategic Research and Development(R&D)
2. Capability Building and R&D Governance
3. R&D Results and Utilization
4. Policy Analysis and Advocacy;

WHEREAS, in order to effectively and efficiently manage and coordinate the program activities to attain its expected outputs, it is necessary to obtain full support and commitment from the Consortium-Member Institutions (CMIs);

WHEREAS, for and in consideration of the above premises, the Local Government Unit of Ormoc City has agreed to support and join the mutual covenant to undertake the management and implementation of the program;

WHEREAS, after review of the draft MOC by the City Legal Office, said office finds nothing legally objectionable therein considering that the same is in order, not contrary to law, morals or public policy;

WHEREAS, upon close and thorough review, this Sanggunian finds that the aforementioned MOC is advantageous and for the best interest of the City, especially the farmers, fisher folks and to the community as a whole;



WE HEREBY AGREE

That the purpose of this consortium is exclusively for the promotion of science, technology and innovation applications in Region 8 for agriculture, aquatic, and natural resources sector through:

1. Strategic Research and Development
2. Capability Building and R&D Governance
3. R&D Results and Utilization
4. Policy Analysis and Advocacy

That the VICARP, as agreed by the majority of its members, shall serve as the host agency of the consortium.

That a Regional Research and Development Coordinating Council (RRDCC) composed of all heads of the participating agencies shall be established and serve as the advisory and policy making body.

That the membership to the consortium is voluntary and an annual contribution shall be paid to the host agency for the operations of the consortium.

That the roles and responsibilities of the CMIs as provided for in the Consortium's Constitution and By-laws shall govern the actions of the members.

That DOST-PCAARRD shall release funds to the science and technology program of the host institution for the operations of the project.

Approved That this agreement shall take effect and continue to be enforced for a period of three (5) years unless otherwise mutually revoked by the concerned parties.




