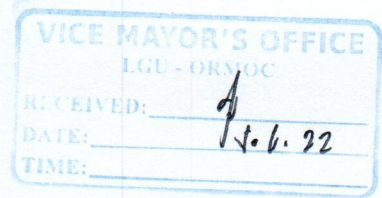
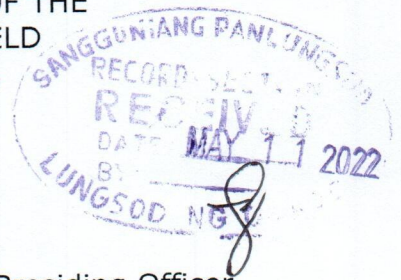

**A RESOLUTION ADOPTING THE EXTENSION OF THE
ORMOC CITY DISASTER RISK REDUCTION AND
MANAGEMENT (DRRM) TERM PLAN 2016-2020 TO
CALENDAR YEAR (CY) 2021-2022 DUE TO COVID-19
PANDEMIC**

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated May 4, 2022 from the Office of the City Mayor, endorsing a request for the issuance of a resolution adopting the extension of the Ormoc City Disaster Risk Reduction and Management (DRRM) Term Plan 2016-2020 to Calendar Year (CY) 2021-2022 due to COVID-19 Pandemic. Further requesting that this matter be treated as EXTREMELY URGENT, a copy of the Indorsement is hereto attached as ANNEX "A" and made an integral part hereof;

WHEREAS, Section 11 (b) of RA 10121 otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010 enumerates the functions of the Local Disaster Risk Reduction and Management Council, to wit: 1.) Approve, monitor, and evaluate the implementation of the LDRRMI's and regularly review and test the plan consistent with other national and local planning programs; 2.) Ensure the integration of disaster risk reduction and climate change adaptation into local development plans, programs, and budgets as a strategy in sustainable development and poverty reduction;

WHEREAS, Presidential Proclamation No. 1021 issued last September 16, 2020 extended the period of State of Calamity throughout the Philippines to afford the National and Local Government Units ample latitude to continue utilizing appropriate funds, in their disaster preparedness and response efforts to contain the spread of COVID-19 and to provide basic services to disaster-affected populations;

WHEREAS, the City of Ormoc and the rest of Region 8, at that time, had been placed under modified community quarantine wherein restrictions on travel, public gatherings, and face-to-face meetings and other health protocols were still in effect;

WHEREAS, the conduct of planning sessions, focus group discussions, and technical support on the implementation of the remainder of the Plan were stalled due to strict observance of minimum public health protocols;

WHEREAS, the 5-Year City Disaster Risk Reduction and Management (CDRRM) Term Plan needs to be continually updated to conform to the new guidelines of the National Disaster Risk Reduction and Management Council (NDRRMC) particularly on emerging infectious diseases;

WHEREAS, a Resolution dated October 12, 2020 issued by the Ormoc City Disaster Risk Reduction and Management Council extended the term of validity of the City Disaster Risk Reduction and Management Plan (CDRRMP) to Year 2021-2022 due to COVID-19 Pandemic, a copy of the Resolution is hereto attached as ANNEX "B" and made an integral part hereof;

WHEREAS, upon thorough examination, this Sanggunian finds the said request for a Resolution extending the CDRRM Plan conforms to the generally accepted principles of law; is reasonable and in order; the same is entered into for the best interests of the City; and, finally, that the adoption of extension of the Plan, among other lawful purposes, prepares the City with contingency measures particularly on emerging infectious diseases and henceforth, deserving of this august Body's prompt and favorable consideration;

WHEREFORE, on motion of SP Member Eusebio Gerardo S. Penserga Chairperson, Committee on Public Safety and Disaster Management, severally seconded by SP Members Tomas R. Serafica, Roiland H. Villasencio, Jasper M. Lucero, Peter M. Rodriguez, Vincent L. Rama, Gregorio G. Yrastorza III, Lalaine A. Marcos, Esteban V. Laurente and Joan Marbie C. Simbajon; be it




