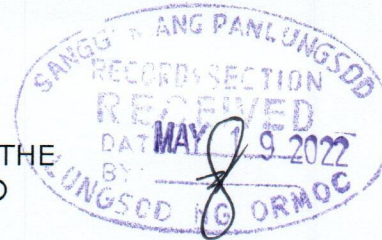

**A RESOLUTION APPROVING AND AUTHORIZING THE
PURCHASE OF ONE (1) UNIT BRAND-NEW SERVICE
VEHICLE FOR THE CITY ADMINISTRATOR'S OFFICE**

WHEREAS, the Sanggunian was in receipt of an Endorsement Letter from the Office of the City Mayor dated April 26, 2022 respectfully requesting for the passage of a Resolution granting authority to purchase a brand-new service vehicle;

WHEREAS, the requested vehicle shall be for the efficient execution of business operations and/or transaction of the City Administrator's Office;

WHEREAS, the City Accountant and the City Budget Officer issued a Certificate of Availability of Funds stating therein that the funds for the aforementioned request are deemed available and are sourced from the CY 2022 General Fund, a copy of the certifications are hereto attached as Annex "A", and made an integral part hereof;

WHEREAS, to recall, this Sanggunian approved Appropriation Ordinance No. 2022-001 otherwise known as the 2022 Annual Budget of the City of Ormoc enacted on December 14, 2021, approving therein a total budget of Thirty-One Million Six Hundred Thousand Philippine Pesos (Php31,600,000.00) under the General Fund intended for Motor Vehicles purchases;

WHEREAS, this Sanggunian finds that the request is meritorious, reasonable and necessary to facilitate the effectiveness and efficiency of the requesting office and improve their capability to accomplish deliverables satisfactorily which will ultimately redound to the benefit of the public, and not contrary to law, public policy and morals, and therefore, is most deserving of this august Body's prompt and full support;
