
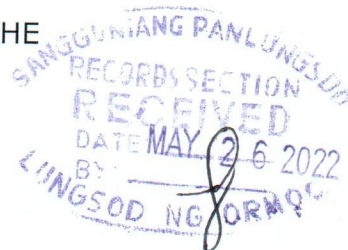

**A RESOLUTION COMMENDING AND GRANTING
INCENTIVES TO THE WINNING ATHLETE IVY CLAIRE
DINOY AND COACHES VENERANDO D. GARCIA AND
AVELINO VICTORINO JR. FOR BRINGING HONOR TO
ORMOC CITY DURING THE 2021 SEA GAMES HELD AT
HANOI, VIETNAM ON MAY 12-23, 2022 PROVIDED
THE REQUIREMENTS ARE COMPLIED, PURSUANT TO
CITY ORDINANCE NO. 064 SERIES OF 2021**

WHEREAS, the City of Ormoc recognizes the youth and sports development as one of the crucial areas in nation building;

WHEREAS, the 2021 Southeast Asian Games or the 31st Southeast Asian Games was held at Hanoi, Vietnam on May 12 -23, 2022 and one of the sports is the Women's Team Epee Fencing;

WHEREAS, Epee fencing is the largest and heaviest of the three weapons used in the sport of fencing, targets the fencer's entire body, and only touches with the tip of the weapon;

WHEREAS, two homegrown Ormocanon athletes in the person of Ivy Claire Dinoy of Barangay Naungan and Samuel German of Barangay Tambulilid assisted by two (2) coaches formed part of the Philippine National Fencing Team bound to the 2021 SEA Games;

WHEREAS, the victory of Ivy Claire Dinoy deserves to be recognized and commended for bringing pride and honor to the Ormocanon youth and for showing to the world the unrelenting spirit of Filipino excellence;



WHEREAS, the Sports Commission recommend the appropriate cash incentives pursuant to City Ordinance No. 064 Series of 2021 to be given to the winning athlete and coaches as follows:

International

a. SEA Games and other international events

Individual

Gold	- Php 100,000.00
Silver	- Php 75,000.00
Bronze	- Php 50,000.00

Team

Gold	- Php 200,000.00
Silver	- Php 150,000.00
Bronze	- Php 100,000.00

Section 4, letter b, paragraph II states that the incentives for the coaches shall be equivalent to fifty percent (50%) of the cash incentives for gold, silver, and bronze medalist. In case of more than one (1) coach, the cash incentives shall be divided among themselves.

Section 5 letter a, subsection III-A indicates that for competitions with less than five (5) participants per team, the individual members of the team shall receive the same cash incentives for individual medal winners provided only members present during the actual competition shall be entitled to such incentives.

WHEREAS, the winning athlete Ivy Claire Dinoy is part of a four-member team. Therefore Ivy Claire Dinoy and coaches Venerando D. Garcia and Avelino Victorino Jr. shall receive the corresponding amount of money, to wit;

I. Winning Coach - two (2) recipients with the total amount of FIFTY THOUSAND PESOS (Php50,000.00)

II. Individual Bronze - one (1) recipient with the total amount of FIFTY THOUSAND PESOS (Php50,000.00)

GRAND TOTAL: ONE HUNDRED THOUSAND PHILIPPINE PESOS (PHP100,000.00)

The required documents pursuant to aforesaid ordinance is hereto attached and made an integral part hereof;
