RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) BY AMONG THE CITY GOVERNMENT OF ORMOC, 2022 ORMOC CITY FIESTA AND ORMOC CHARTER DAY EXECUTIVE COMMITTEE, ORMOC **FESTIVAL** CULTURAL FOUNDATION, INC. (OFCF), OCCIDENTAL LEYTE BAR ASSOCIATION (OLBA), AND PHILIPPINE INSTITUTE OF CERTIFIED PUBLIC ACCOUNTANTS (PICPA) - ORMOC FOR THE CONDUCT OF VARIOUS SOCIO - CULTURAL ACTIVITIES FROM MAY 15 TO OCTOBER 31, 2022, IN RELATION TO ORMOC CITY FIESTA AND ORMOC CHARTER DAY CELEBRATIONS

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated May 24, 2022 from the Office of the City Mayor, endorsing a request for the issuance of a Resolution granting the City Mayor or Acting City Mayor the authority to sign the Memorandum of Agreement (MOA) to be entered into by and among the City Government of Ormoc, 2022 Ormoc City Fiesta and Ormoc Charter Day Executive Committee, Ormoc Festival and Cultural Foundation, Inc. (OFCF), Occidental Leyte Bar Association (OLBA), and Philippine Institute of Certified Public Accountants (PICPA)-Ormoc for the conduct of various socio-cultural activities for the months of June and October 2022. Further requesting that this matter be treated as EXTREMELY URGENT, a copy of the MOA is hereto attached as "ANNEX A" and made an integral part hereof;

WHEREAS, in an Annotation dated May 24, 2022 the City Legal Office finds nothing legally objectionable in the said MOA and that the same is not contrary to law, morals, public order, or public policy much less detrimental to the best interests of Ormoc City;

WHEREAS, LGU-Ormoc's Executive Order No. 261, Series of 2022 created and organized the 2022 Ormoc City Fiesta and Ormoc Charter Day Executive Committee which is tasked to coordinate, among others, socio-cultural activities for the months of June and October 2022 involving various programs, activities, and events that need the active participation of multiple sectors in the city, from the government, business, civic clubs, professional organizations, and doctrinal groups;

WHEREAS, the month of June is recognized as a significant date to the City of Ormoc as the annual mid-year celebrations present various major social and cultural opportunities that promote tourism and dynamic interaction in the local economy;

WHEREAS, it is recognized that the City of Ormoc will commemorate its 75th year of being a chartered city on October 20, 2022;

WHEREAS, the City Government of Ormoc, cognizant of the positive impact of the socio-cultural activities between May 15 to June 30, 2022 and October 1 to 30, 2022 to the local economy, fully supports the conduct of this important event;

This Memorandum of Agreement made and entered into by and among:

The CITY OF ORMOC, herein referred to as *Ormoc LGU*, a local government unit with principal address at the New Ormoc City Hall, Aunubing Street, Ormoc City, represented herein by its Mayor, RICHARD I. GOMEZ;

The 2022 ORMOC CITY FIESTA and ORMOC CHARTER DAY EXECUTIVE COMMITTEE, herein referred to as the *Committee*, is a special committee created for the 2022 socio-cultural and sports events celebrations for June 2022 and October 2022 in the city, represented herein by its Overall Chairman, MR. JUDE P. ABENOJA, CPA;

The ORMOC FESTIVAL AND CULTURAL FOUNDATION, INC., herein referred to as *OFCF*, a non-government organization with principal address at Ormoc City, represented herein by MS. ESTRELLA MARIA SERAFICA-PANGILINAN;

The OCCIDENTAL LEYTE BAR ASSOCIATION herein referred to as *OLBA*, a non-government, non-stock, non-profit organization with principal address at Ormoc City, represented herein by MS. CHELISSA MAE ROJAS;

and

The PHILIPPINE INSTITUTE OF CERTIFIED PUBLIC ACCOUNTATS OR OC CITY CHAPTER, herein referred to as PICPA a non-government organization with principal address at Ormoc City, represented herein by MS. GEMMA FLOR C. CORBO, CPA;

WITNESSETH: THAT:

WHEREAS, LGU Ormoc Executive Order No. 261, Series of 2022 created and organized the 2022 ORMOC CITY FIESTA and ORMOC CHARTER DAY EXECUTIVE COMMITTEE which is tasked to coordinate, among others, sociocultural activities for the months of June and October 2022, involving various programs, activities and events that need the active participation of multiple sectors in the city, from the government, business, civic clubs, professional organizations, and doctrinal groups;

WHEREAS, the OLBA and PICPA are organizations of professionals based in, ORN'CCCIPOEGNATIFICTOOTS in Ormoc City, existing and operating under relevant laws, and are accredited Civic Society Organizations with the LGU Ormoc;

WHEREAS, the OFCF is a cultural foundation based in Ormoc City, and is an Separate activitied ted foundation with the LGU Ormoc;

WHEREAS, it is recognized that the month of June is significant to the City of Ammend of Marious major social on the Major Roman and cultural opportunities that promote tourism in the City of Ormoc and boost the local Deconomy.

WHEREAS, it is also recognized that Ormoc will commemorate its 75th year of being chartered as a city on October 20, 2022;

WHEREAS, the OLBA, as member of the Committee have been tasked to take charge of the collection of funds and compilation of disbursements and expenses for the socio-cultural activities subject of this Memorandum, all of which are not incomegenerating activities for the OLBA, or any of the parties herein. All remittances and payments to the BIR and other government regulatory agencies, when pertinent and required, shall be paid for on behalf of the Committee;

WHEREAS, the PICPA, as member of the Resource Generation has been tasked to generate the needed funds for the socio-cultural and other activities on the occasion of the Ormoc City Socio-Cultural and Sports Events for June and October 2022, which are, likewise, not income-generating for the organization;

WHEREAS, LGU Ormoc, cognizant of the positive impact of the socio-cultural activities between May 15 to June 30, 2022 and October 1 to 30, 2022 to the local economy, fully supports the conduct of this event in the city.

WHEREAS, all PARTIES agree that the net proceeds collected from the ORMOC CITY SOCIO-CULTURAL AND SPORTS EVENTS celebrations leading and/or related to June 29, 2022 and October 20, 2022, will be delivered to the City Government of Ormoc to partially fund the Ormoc City Museum.

NOW, THEREFORE, for and in consideration of the foregoing premises, the PARTIES agree to the following:

I. Scope of Agreement

This agreement shall cover the organization, preparation and conduct of the sociocultural activities for the period of May 15, 2022 to October 31, 2022.

II. Organizational Set-Up

The following is the organizational set-up in the implementation of the terms of this agreement:

Overall Organizer - Committee
Resource Generation - PICPA
Finance - OLBA

Piña Festival - Ormoc Festival and Cultural Foundation

Host LGU - LGU Ormoc

The Committee Chairman shall act as the Overall Chairman, the PICPA as GRAVOC CITY LEGAL OF Resource Generation, the OLBA representative as Finance Chairman, and the Ormoc City Mayor as the Honorary Chairman.

A. The Committee shall:

Drafted by CLO Wa. Provide overall direction in the conduct of the socio-cultural activities between May 15 to June 30, 2022 and October 1 to 31, 2022 for and in the City of Ormoc;

b. Provide assistance in generating sponsors;

c. Provide secretariat support for preparatory activities and during the Ammendments/Revisions conduct of the said activities;

d. Promote the event through local and/or national tri-media;

- Encourage participation in the various socio-cultural activities among its stakeholders and partners;
- f. Provide technical and administrative support;
- g. Approve, through the Finance Chairman, all Liquidation Reports and/or Reimbursement of Expenses Reports, including vouchers and other accounting and administrative forms submitted by all committee heads in the format as prescribed by the OLBA;
- h. Approve the reimbursement of the Resource Generation and/ or Finance committees' management and administrative cost and expenses, including payment of taxes, permits and other fees; and possible disallowances from the BIR (not more than 18% of the total gross receipts). Note: The Committee shall not hold OLBA liable for any losses related to the socio-cultural and sports events.

B. The PICPA shall:

a. Spearhead the generation of funds from May to October 31, 2022, for the socio-cultural activities between May 15 to June 30, 2022 and October I to 30, 2022 including, but not limited to: sponsorships/solicitations, booth/bazaar, food and theme park rentals, ticket sales on all activities, souvenirs, sectoral nights' registration fees LGU funding for sociocultural and sports activities and other special events;

C. The OLBA shall:

- a. Collect and issue Official Receipts (OR) to all sponsors and other fundgeneration activities under the name of Occidental Leyte Bar Association;
- b Require all committee heads to submit Official Receipts (OR), Sales Invoices and other BIR acceptable documents, under the name of the Occidental Leyte Bar Association or OLBA as support for all dishursements and expenses incurred related to the celebrations subject of this agreement in a form of Liquidation Report or Reimbursement of Expenses Report as approved by the Committee Chairman. Note: Refer to OLBA's standard templates;
- Conduct meetings with all committee heads regarding compliance and submission of all reports, including liquidation of expenses, and updating of committee's assignments and other deliverables;
- Compile and submit regular financial reports to the Committee on a weekly basis, or as needed;
- e. Submit to the Bureau of Internal Revenue (BIR) and other government regulatory agencies all compliance reports including certificates of donation to requesting sponsors, as required;
 - Shall facilitate processing of permits and other BIR related requirements (i. permit to print, etc.) and remittance of payment of taxes as required;
 - Supmit audited financial statements for the period May 15 to June 30, 2022 not later than August 31, 2022, and October 1 to 31, 2022 not later than December 10, 2022.
