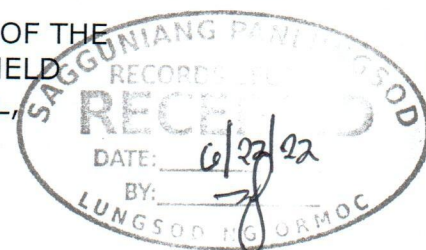

**A RESOLUTION GRANTING AUTHORITY TO THE CITY
MAYOR, RICHARD I. GOMEZ, OR THE ACTING CITY
MAYOR TO ENTER INTO AND SIGN THE
MEMORANDUM OF AGREEMENT (MOA) BY AND
AMONG THE PHILIPPINE STATISTICS AUTHORITY
(PSA), DEPARTMENT OF INTERIOR AND LOCAL
GOVERNMENT (DILG) AND THE LOCAL GOVERNMENT
UNIT OF ORMOC (LGU-ORMOC), FOR THE CONDUCT
OF THE COMMUNITY-BASED MONITORING SYSTEM
(CBMS)**

WHEREAS, an indorsement was forwarded to this august Body from the Office of the City Mayor, dated April 28, 2022, requesting for an issuance of a resolution granting authority to the City Mayor on his representative to enter into and sign the Memorandum of Agreement (MOA) by and among the Philippine Statistics Authority (PSA), Department of Interior and Local Government (DILG) and the Local Government Unit of Ormoc, for the conduct of the Community-Based Monitoring System (CBMS);

WHEREAS, the Community-Based Monitoring System (CBMS) is an organized technology-based system of collecting, processing, and validating necessary disaggregated data that may be used for planning, program implementation, and impact monitoring at the local level while empowering communities to participate in the process;

WHEREAS, the PSA shall be the lead agency in the implementation of the CBMS pursuant to Republic Act (RA) No. 11315 also known as the CBMS Act;

WHEREAS, Rule VI, Section 7 of the Implementing Rules and Regulations of the CBMS Act tasked the DILG to develop and implement information and education campaign relating to CBMS; ensure compliance of the LGUs in the various CBMS activities; and extend assistance to PSA in the conduct and implementation of the CBMS;

WHEREAS, pursuant to Section 4 of the CBMS Act, a CBMS is established and instituted in every city and municipality as an economic and social tool towards the formulation and implementation of poverty alleviation and development programs. Thus, LGU's are mandated to conduct a regular and synchronized data collection every three (3) years;

WHEREAS, this Sanggunian, upon thorough review and examination of the aforementioned MOA finds that: the same is not contrary to law, existing contract, public policy, customs and morals and that it is reasonable and in order and the same is entered into for the best interest of the City and therefore is most worthy of prompt and favorable action;

WHEREFORE, on motion of SP Member Nolito M. Quilang, Chairperson, Committee on Laws and Ordinances, severally seconded by SP Members Tomas R. Serafica, Jasper M. Lucero, Roiland H. Villasencio, Peter M. Rodriguez, Vincent L. Rama, Gregorio G. Yrastorza III, Esteban V. Laurente and Joan Marbie C. Simbajon; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, RICHARD I. GOMEZ, OR THE ACTING CITY MAYOR TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) BY AND AMONG THE PHILIPPINE STATISTICS AUTHORITY (PSA), DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG) AND THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), FOR THE CONDUCT OF THE COMMUNITY-BASED MONITORING SYSTEM (CBMS);


ADOPTED, June 20, 2022.
