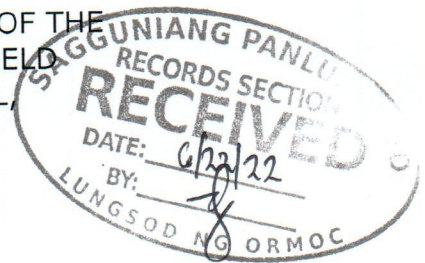

**RESOLUTION NO. 2022-154**

**A RESOLUTION GRANTING AUTHORITY TO THE CITY  
MAYOR, RICHARD I. GOMEZ, OR THE OIC/ ACTING  
CITY MAYOR, TO ENTER INTO AND SIGN THE  
MEMORANDUM OF UNDERTAKING (MOU) FOR AND  
ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF  
ORMOC (LGU-ORMOC) WITH THE DEPARTMENT OF  
AGRARIAN REFORM REGIONAL OFFICE VIII FOR THE  
CREATION OF JOINT SURVEY TEAM**

WHEREAS, this august Body was in receipt of an endorsement from the City Mayor's Office, dated June 17, 2022, requesting for an issuance of a resolution granting authority to the City Mayor or his representative to enter into and sign the Memorandum of Undertaking (MOU) with the Department of Agrarian Reform (DAR) Regional office VIII, for the creation of Joint Survey Team.

WHEREAS, under Republic Act. No. 6657, as amended, the Department of Agrarian Reform is mandated to conduct land acquisition and distribution on covered landholdings;

WHEREAS, under DAR Administrative Order No. 01 Series of 2020 amending DAR Administrative Order No. 07 Series of 2011, the installation of Agrarian Reform Beneficiaries on the landholdings awarded to them is the culmination of the land acquisition and distribution activity on covered landholdings;

WHEREAS, the City Government of Ormoc City and the top officials of DAR Central, Regional, and Municipal Offices participated in a dialogue where they explored areas of cooperation for purposes of expediting the installation of the Agrarian Reform Beneficiaries (ARBs) named in the Collective CLOAs;



WHEREAS, for purposes of installation of Collective CLOA areas, it is necessary that there should first be a subdivision survey conducted on the Collective CLOA in order to determine the exact boundaries for the individual ARBs;

WHEREAS, DENR-DAR Joint Circular No. 06 Series of 1991 provides for the operational guidelines for undertaking surveys on private agricultural lands covered by the Comprehensive Agrarian Reform Program;

WHEREAS, Section 17 of the Local Government Code, provides, "Local Government units xxx also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code. Local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities enumerated herein";

WHEREAS, the City Government of Ormoc, in pursuit of the general welfare of its citizens, particularly the Agrarian Reform Beneficiaries who will benefit from the subdivision of Collective CLOAs, has proactively offered its resources in order to assist in the survey and subdivision of the Collective CLOAs;

WHEREAS, in an annotation the City Legal Office finds nothing legally objectionable in the said MOU and that the same is not contrary to law, morals, public policy much less detrimental to the best interests of Ormoc City;

WHEREAS, the subject MOU clearly and plainly encapsulates the terms and conditions of the agreement of the parties thereto, including their specific roles and obligations towards the attainment of the lofty ends of the same, and this Sanggunian, upon thorough review, finds that the same is entered into for the best interest of the City and its constituents, and therefore most deserving of this august body's prompt and favorable consideration;

WHEREFORE, on joint motion of SP Member Tomas R. Serafica, Chairperson, Committee on Agriculture, Fisheries and Agrarian Reform and SP Member Nolito M. Quilang, Chairperson Committee on Laws and Ordinances, severally seconded by SP Members Roiland H. Villasencio, Vincent L. Rama, Esteban V. Laurente and Joan Marble C. Simbajon; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, RICHARD I. GOMEZ, OR THE OIC/ ACTING CITY MAYOR, TO ENTER INTO AND SIGN THE MEMORANDUM OF UNDERTAKING (MOU) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE DEPARTMENT OF AGRARIAN REFORM REGIONAL OFFICE VIII FOR THE CREATION OF JOINT SURVEY TEAM;


RESOLVED FURTHER, that a copy of the final and notarized Memorandum of Understanding (MOU) be furnished to this Sanggunian for its information and files;
