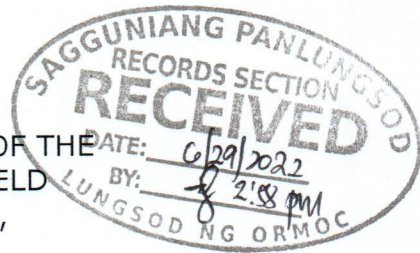

**A RESOLUTION AMENDING RESOLUTION NO. 2022-131 ENTITLED: "A RESOLUTION COMMITTING THE AMOUNT OF SEVEN MILLION SEVEN HUNDRED THIRTY-FIVE THOUSAND FOUR HUNDRED TWENTY-THREE PHILIPPINE PESOS AND 79 CENTAVOS (PHP7,735,423.79) AS THE CITY'S COUNTERPART FUND FOR THE NHA'S HOUSING PROGRAM IN BARANGAY MABINI, THIS CITY, TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF 2021", TO FURTHER COMMIT TO APPROPRIATE ON THE ACTUAL AMOUNT OF UNDERTAKING BY THE CITY TO SAID PROJECT SUBJECT TO APPLICABLE ACCOUNTING AND LEGAL PRINCIPLES**



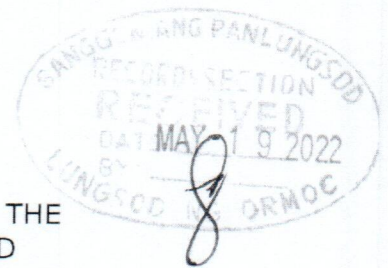

**RESOLUTION NO. 2022-131**

**A RESOLUTION COMMITTING THE AMOUNT OF SEVEN MILLION SEVEN HUNDRED THIRTY-FIVE THOUSAND FOUR HUNDRED TWENTY-THREE PHILIPPINE PESOS AND SEVENTY-NINE CENTAVOS (PHP7,735,423.79) AS THE CITY'S COUNTERPART FUND FOR THE NHA'S HOUSING PROGRAM IN BARANGAY MABINI, THIS CITY, TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF 2021**

WHEREAS, this august Body was in receipt of an Endorsement from the City Mayor's Office dated April 28, 2022, requesting for the issuance of a Resolution committing to appropriate the amount of Php7,735,423.79 and such amount to answer for import fill, grading and compaction, LARES individual lot titling and anaerobic baffled reactor for the site to be workable for the said housing project, subject to applicable accounting and legal principles;

WHEREAS, the Committee on Zoning, Housing and Land Use, Committee on Finance and Appropriation, and Committee on Public Properties had a Tripartite Committee Meeting last May 12, 2022, together with the different offices, Ormoc City Housing, City Planning, City Accounting and City Budget;

WHEREAS, the Ormoc City Housing Office discussed the items of work under "Earthworks", "Survey Works" and "Sewerage System" are Ormoc City's counterpart funds to the project;

WHEREAS, the abovementioned items of work are broken down as follows:

- a) Php5,739,285.20 for the Import Fill, Grading and Compaction under "Earthworks";



- b) Php135,822.69 for the LARES Individual Titling under "Survey Works"; and
- c) Php1,860,315.90 for the 8.5m x 16m x 3.2 Anaerobic Baffled Reactor under the "Sewerage System".

For a total cost of Php 7,735,423.79, to be funded by the LGU-Ormoc;

WHEREAS, the Local Finance Committee suggested that the counterpart funds then be taken out from the city's unappropriated funds, end of 2021;

WHEREFORE, on motion of SP Member Jasper M. Lucero, Chairperson, Committee on Public Properties together with SP Member Roiland H. 


