(3) The film company must keep the "curious public" at a mini mum distance of ten (10) meters from the camera or crew which ma be going about their business. If necessary and available, a mem of the Police Force of the City shall be assigned by the Chief o Police to maintain order.

SECTION 4.1.8.4. Penalty. . Any film company that shall viola the provisions of this article shall have his permit revoked imm diately without refund of whatever fees that may have been advan He shall suffer an additional fine of one hundred pesos (P100.00 destierro upon recommendation of the proper court.

Article 15 - Water Service and Conditions of Installation

SECTION 4.1.9.2. Exemption. Any owner of land traversed by pipes of the system, or the owner of the land where the source of water comes from, shall be allowed a minimum of FREE CONSUMPTION water not exceeding thirty (30) cubic meters per month, and that excess of the same, the said owners of the land shall be charged PO.50 per cubic meter for domestic use and PO.75 per cubic meter commercial use.

SECTION 4.1.9.3. Time of Payment. - Payment of the consumption of water shall be made at the office of the Waterworks Superinter dent within ten (10) days of the succeeding month. Installation reopening fees are payable in advance.

SECTION 4.1.9.4. Accrual of Fees. - Starting January 1, 1977 December 31, 1987, revenues collected by the Ormoc Waterworks Sys after deducting cost of operation and improvements, shall accrue a special trust fund which shall only be exclusively used for the continuing improvement program of the system and its future extesions to newly urbanized areas of the City of Ormoc. SECTION 41.9.5. Penalty for delinquency. - Non-payment of water bills for a triod of six (6) months shall be sufficient cause of disconnection of water pipes to the customer, without prejudice to the collection of the unpaid obligation plus interest of twelve (12 per centum per annum until the amount is fully paid.

## TITLE V FINAL PROVISIONS

SECTION 5.0...l. Explanatory Clause. - Whenever a provision requires that an fficial of the City Government shall be responsible for issuing permits and providing rules therein, and such government official has notbeen appointed, nor has his item been created by the Sangguniang Lyan, it shall devolve upon the Office of the Mayo to furnish the sevices provided herein.

SECTION 5.0.02. Administrative Authority of the City Treasurer The City Treasurer shall formulate forms and issue such regulations as may be needed for time to time for the proper, effective and efficient implementation of this Code.

SECTION 5.0.0.3 Issuance and Revocation of Permits and Licenses The issuance and repeation of permits and licenses must not be unjust, oppressive, dscriminatory, or in restraint of trade.

SECTION 5.0.0.4. epealing Clause. All ordinances, rules and regulations, or part thereof, which are inconsistent with any provision or provisions of this Code are hereby repealed or modified accordingly.

SECTION 5.0.0.5. Acrual to the General Fund. - Unless otherwis provided by law or or nances, fines, costs, forfeitures and pecuniary liabilities import by the courts for violation of any ordinan shall accrue to the Geral Fund.

SECTION 5.0.4.5. E-trability Clause. - Should any provision, section or part of thi Code be adjudged invalid by any court of competent jurisdiction, such judgment shall not affect nor impair the remaining provision, sections or parts which provisions, sections or parts shall cotinue to be in force and effect.

SECTION 5.0.0.7. Effetivity. - This Code shall take effect on
