RESOLUTION NO. 511

Presented for consideration is the proposed ordinance amending Sections 4.1.1.7 and 4.1.1.8 of Tax Ordinance No. 1, otherwise known as the "Ormoc City Revenue Code of 1977" which amendments have been agreed by market stall holders in a public hearing jointly conducted by the Committee on Markets and Slaughterhouses and Committee on Laws and Ordinances;

NOW, THEREFORE, on motion of Kagawad Besabella, seconded jointly by Nga Kagawad Porcadilla and Kangleon; be it

RESOLVED, to adopt:

TAX ORDINANCE NO. 3

AN ORDINANCE AMENDING SECTIONS 4.1.1.7 AND 4.1.1.8 OF TAX ORDINANCE NO. 1, OTHERWISE KNOWN AS THE "ORMOC CITY REVENUE CODE OF 1977".

BE IT ENACTED, By the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Amendment. - Section 4.1.1.7 of Tax Ordinance No. 1, otherwise known as the "Ormoc City Revenue Code of 1977", is hereby amended to read as follows:

"SEC. 4.1.1.7. Rates of rentals of fixed stalls, booths, and tiendas. - There is hereby imposed and collected from each and every person or entity engaged in business within the public market and its premises the following presented rates of market fees per square meter a day or a fraction thereof on stalls occupied therein:

"(a) Fish section ..... P1.30

(b) Meat section ..... 1.75



- (c) Dry goods, groceries  
and foodstuffs section .... P0.85

"Vendors of dry goods, groceries and other foodstuffs shall be understood to mean and include:

- "(1) Dealers of salted or dried fish;
- (2) Vendors of rice, palay, corn and other cereals;
- (3) Vendors of vegetables, fruits, and the like;
- (4) Dealers in any goods;
- (5) Carenderias, sari-sari stores, 'panciterias', refreshment parlors and other allied business; and
- (6) Retail dealers in tuba, soft drinks, and other beverages.

"Other business ventures not mentioned above, but occupying a stall or space in the public market shall, however, be levied each a market fee of fifty centavos (P0.50) per square meter a day."

SECTION 2. Amendment. - Section 4.1.1.8 of Tax Ordinance No. 1, otherwise known as the "Ormoc City Revenue Code of 1977", is hereby amended to read as follows:

"SEC. 4.1.1.8. Market fees for the occupancy of market premises. - For occupying market premises, but not occupying stalls, or permanent spaces therein, there is hereby imposed and collected the following fees, to wit:

- "1. Wholesale dealer of salted bolinao, per petroleum can ..... P0.40
2. Wholesale dealer of bodo and tabagak fish: (a) per big box ... 0.80  
(b) per small box . 0.60
3. Wholesale dealer of dried bolinao (dilis), libod, quiampe:  
(a) per big box .. 0.50  
(b) per small box. 0.40
4. Wholesale dealer of any other salted or dried fish not included above, per box ..... 0.40
5. Vendors of crabs or other seafoods 0.20
6. Vendor of clams (imbaw) or similar seafoods ..... 0.20
7. Vendor of other sea shells ..... 0.20
8. Vendor of cooked banana, young corn, camote or cassava ..... 0.20
9. Vendor of banana (uncooked) .... 0.20

- "10. Vendor of camote, young  
corn, cassava (Uncooked) ..... P0.20
11. Vendor dealing other articles  
or foods other than those  
mentioned above ..... 0.20"


SECTION 3. Effectivity. - This Tax Ordinance shall take effect immediately upon its approval.

ENACTED, January 17, 1978.


RESOLVED, FURTHER, to furnish a copy of this Tax Ordinance each to the Honorable Secretary of Finance, Metro Manila; the City Treasurer, the Market Administrator, the Filipino Retailers Association, the Market Vendors Association, and all stall holders, Public Market, in the City of Ormoc;

CARRIED. Fourteen (14) votes; Kagawad Lladoc was out during the voting.
