TAX ORDINANCE NO. 4

AN ORDINANCE TO AMEND ITEMS 5 AND 6 UNDER SECTION 1
OF ORDINANCE NO. 12 (TAX ORDINANCE NO. 2)

Be it Ordained, by the Sangguniang Panlungsod ng Ormoc,
That:

SEC. 1. Amendments.- Items 5 and 6 under Section 1 of
Ordinance No. 12 (Tax Ordinance No. 2) amending Tax Ordinance
No. 1 series of 1976, entitled "AN ORDINANCE CODIFYING THE
TAX AND OTHER REVENUE ORDINANCES OF THE CITY OF ORMOC, OTHER-
WISE KNOWN AS THE ORMOC CITY REVENUE CODE OF 1977" are hereby
amended to read as follows:

"5. Item "a" of Section 2.2.1.1., entitled "Imposition
of Tax" (Page 20) shall read:

"a. Lawyers, medical practitioners, civil engineers,
professional electrical engineers, mechanical engineers
(either junior or professional), chemical engineers, mining
engineers, sanitary engineers, agricultural engineers, elec-
tronics and communications engineers, mechanical plant

engineers, certified public accountants, architects, naval architects, dentists, pharmacists, optometrists, opticians, licensed shipmasters (master mariners), commercial aviators, marine chief engineers (chief motor engineers), veterinarians, customs brokers, marine surveyors, actuaries, registered electricians, interior decorators, registered master plumbers, professional appraisers or connoisseurs of tobacco and other domestic or foreign products, certified plant mechanics, sugar technologists, real state brokers, stock brokers, medical technologists, insurance agents, sub-agents and geodetic engineers. "6. The fifth paragraph of Section 2.2.2.5 (Pages 28-30) shall read:

"The following shall be considered business establishments which principally render or offer to render services to the public and shall pay according to the schedule hereunder:
