RESOLUTION NO. 846

"WHEREAS, the City Treasurer in his letter of June 30, 1980, has recommended an amendment to Section 3.2.4.1 under Article 4 of Chapter 2 of Tax Ordinance No. 1, otherwise known as the "Ormoc City Revenue Code of 1977", more particularly Item "h" thereunder, by increasing the payment of bicycle number plates from P3.50 to P4.50 in view of the increased cost of acquisition of plates;

"WHEREAS, this august Body concurs in the recommendation of the City Treasurer and would even add the increase to P5.00 in anticipation of a new increase in energy cost which rate should, of course, be included not only for bicycle but also for sidecar, ice-cream cart, carromata, caretela or calesa locally called 'tartanilla' or 'parada';

"NOW, THEREFORE, on motion of Kagawad Tugonon, seconded jointly by Mga Kagawad Mendola, Santiago and Hermosilla; be it

"RESOLVED, to adopt:

TAX ORDINANCE NO. 8

AN ORDINANCE TO AMEND ITEM "H" OF SECTION 3.2.4.1 UNDER ARTICLE 4 OF CHAPTER 2 OF TAX ORDINANCE NO. 1

BE IT ENACTED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Amendment. - Item "h" of Section 3.2.4.1 under Article 4 of Chapter 2 of Tax Ordinance No. 1, otherwise known as the "Ormoc City Revenue Code of 1977" is hereby amended by increasing the payment for number plates from P3.50 to P5.00 per annum so that said item will now read:

"(h) Plates (for bicycle, sidecar, ice-cream cart, carromata, caretela or calesa locally known as 'tartanilla' or 'parada')..... P5.00"

SECTION 2. Effectivity. - This Tax Ordinance shall take effect thirty days upon approval or immediately upon implementation of the new energy or oil price increase.

ENACTED, July 15, 1980.

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer and all owners of bicycles, sidecars, ice-cream carts, carromatas, caretelas/tartanillas/paradas, all in the City of Ormoc;
