RESOLUTION NO. 874

Presented for consideration is the long standing request of the City Treasurer for the reduction of the daily rentals to be charged for the occupancy of interior market stalls which have been left vacant for some time already. According to his letter dated June 26, 1980, his office has conducted a survey among market stallholders as to the reasonable daily rental for each interior market stall and from such survey there came up a proposed rate of P5.50 per day, i.e., P0.3431 per square meter per day, which is less than one-half (1/2) of the current daily rate of P13.60 or P0.85 per square meter per day, as provided for in Item "c" of Section 4.1.1.7 of Tax Ordinance No. 1, as amended, otherwise known as the "Ormoc City Revenue Code of 1977";

In order to compensate for the loss of market revenue arising out of the long-existing vacancies, the City Treasurer recommended that the daily rental for interior market stalls be fixed at P6.80 or one-half (1/2) of the current rate which his office deems to be reasonable, in other words, following the revenue code language, P0.45 per square meter per day;

The Sanggunian Committee on Markets and Slaughterhouses chair-manned by the Honorable Dionisio S. Santiago was then authorized to conduct its own survey and investigation in, particularly, Building "B" comprising the Grocery Section which includes, more particularly, Row 1 - Stalls Nos. 10, 14, 18, 22, 26, 30, 34, 38, 42, 46, 50, 54, 58, 62. Row 2 - Stalls Nos. 3, 7, 11, 15, 19, 23, 27, 31, 35, 39, 43, 47, 51, 55, 59, 63 and Building "C" comprising the Dried Fish Section which includes: Row 1 - Stalls Nos. 66, 70, 74, 78, 82, 86, 90, 94, 98, 102, 106, 110. Row 2 - Stalls Nos. 71, 75, 79, 83, 87, 91, 95, 99, 103, 107, 111;

The Committee on Markets and Slaughterhouses finds the recommendation of 50% reduction of daily rental quite low considering that the City has still an obligation to the Development Bank of the Philippines on the three market buildings. After a lengthy deliberation it was finally agreed that the daily rental for the particular stalls should be P8.00, that is, P0.50 per square meter per day which is P5.60 less per day or P0.35 less per square meter per day than the current rate;

TAX ORDINANCE NO. 9
AN ORDINANCE TO AMEND ITEM "C" OF SECTION 4.1.1.7
OF TAX ORDINANCE NO. 1

BE IT ENACTED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Amendment. - Item "c" of Section 4.1.1.7 under Title IV, Chapter I, Article 1 of Tax Ordinance No. 1, otherwise known as the "Ormoc City Revenue Code of 1977", is hereby amended to read as follows:

"(c) Dry goods, groceries and foodstuffs section 0.85:

PROVIDED HOWEVER, that the following interior stalls shall be charged at the rate of fifty centavos (P0.50) per square meter a day:

Building "B" (Grocery Section) - Stalls Nos. 3, 7, 10, 11, 14, 15, 18, 19, 22, 23, 26, 27, 30, 31, 34, 35, 38, 39, 42, 43, 46, 47, 50, 51, 54, 55, 58, 59, 62, and 63;
Building "C" (Dried Fish Section) - Stalls Nos. 66, 70, 71, 74, 75, 78, 79, 82, 83, 86, 87, 90, 91, 94, 95, 98, 99, 102, 103, 106, 107, 110, and 111."

SECTION 2. Effectivity. - This Tax Ordinance shall take effect immediately upon its approval.






