AN ORDINANCE TO AMEND SECTION 3 OF TAX ORDINANCE NO. 10

BE IT ENACTED, by the Sangguniang Panlungsod mg Ormoc, That:

SECTION 1. Amendment. - Section 3 of Con Ordinance No. 10, otherwise known as the "Crmoc Seawall Utility Ordinance," is hereby amended to read as follows:

SECTION 3. Utility ree. - There shall be paid by the person of the consignee, patural or juridical, to the City Treasurer in his duly authorized representative a utility fee of one peso and fifty centavos (F1.50) per metric ton/ oubic me'er of orgoes loaded or unloaded to or from vessels availing themselves of the facilities of the seawall and other protective development projects along Imelda Boulevard and the vicinity of the public market complex of Ornoc City: PROVIDED, HOWEVER, That in cases where cargoes are to be delivered by the shipper right at the job site or in case of contract deliveries where the contract specifies that payment for the incidental expenses shall be bofne by the shipper, the utility fee shall be paid by such shipper: PROVIDED, FURTHER, That any privately owned or rented truck, prime mover with trailer, other vehicles and the like equipment standing by, using the facilities of the area described in Section 1 hereof shall be charged as follows:

PROWIDED, FINALLY, That as a condition precedent for the use of the Ormoc seawall the Mayor's permission should first be secured.
