TAX ORDINANCE NO. 12

AN ORDINANCE TO AMEND, FURTHER, SECTION 4.1.7.1 OF ARTICLE 13,
TAX ORDINANCE NO. 1, OTHERWISE KNOWN AS THE "ORMOC CITY
REVENUE CODE OF 1977", AS AMENDED BY TAX ORDINANCE NO. 5

BE IT ENACTED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Amendment. - Section 4.1.7.1 of Article 13, Tax Ordinance
No. 1, otherwise known as the "Ormoc City Revenue Code of 1977", as amend-
ed by Tax Ordinance No. 5, is hereby amended further to read as follows:

"SECTION 4.1.7.1. Imposition of Fees. - Except as herein-
after provided, the following fees shall be paid by each student
enrolled in the Ormoc City High School, to wit:

First Year	P2.00	P150.00
Second Year	2.00	155.00
Third Year	2.00	165.00
Fourth Year	2.00	175.00

SECTION 2. Effectivity. - This Ordinance shall take effect immedi-
ately upon the approval of the Minister of Education and Culture.
