"The Sangguniang Panlungsod ng Ormoc, on motion of Kagawad Besabella, seconded jointly by Mga Kagawad Mendola, Bandalan and Codilla;

"RESOLVED, to adopt:

AN ORDINANCE TO AMEND SECTIONS 4.V.1.13 AND 4.1.3.6
OF TAX ORDINANCE NO. 1, OTHERWISE KNOWN AS THE
"ORMOC REVENUE CODE OF 1977."

BE IT ORDAINED, by the Sanguniang Panlungsod ng Ormoc, That:

SECTION 1. Tax Code Amendment to Section 4.1.1.13. - Section 4.1.13 of Tax Ordinance No. 1, otherwise known as the "Ormoc City Revenue Code of 1.77", is hereby amended to read as follows:

Merchandise or Animals

"SECTION 1.1.13. Fees from Persons Selling in Trucks,
Boats and the Market Vicinity. - The City Treasurer, through
his authorized representatives in the city markets, shall collest fees from persons selling merchandise in trucks, in conveyances or in boats docked or moored in the waters of the harbors
in the vicinity of the city markets or in any other places within the territorial jurisdiction of the City of Ormoc according
to the following schedule of rates:

It shall be the duty of operators and/or drivers of trucks, captains or skippers or watercrafts and other conveyances containing merchandise upon arrival in any city market and before unloading and/or selling or offering for sale the merchandise or

animals carried in the same immediately to report to the Market Collectors their presence in the said market in order that the latter could determine the exact amount of fees they a r e required to pay: Provided, however, That any violation of this provision shall render such owner or owners subject to the payment of special fees representing twice the amount of market fees to be determined pursuant to the capacity and/or volume of merchandise so unloaded or sold without previous notification to the Market Administrator or to the Market Collectors as provided in this Section."

SECTION 2. Tax Code Amendment to Section 4.1.3.6. Section 4.1. 3.6 of Tax Ordinance No. 1, otherwise known as the "Crmoc City Revenue Code of 1977", is hereby amended to read as follows:

"SECTION 4.1.3.6. Market Hours. - The public markets shall be open for the sale of articles or merchandise permitted f o r sale therein from THREE o'clock in the morning watil TEN o'clock in the evening every day."

SECTION 3. Effectivity. - This Ordinance shall take affect immediately upon its approval.
