"RESOLVED, to adopt:

TAX ORDINANCE NO. 16

AN ORDINANCE TO AMEND ITEM 12 OF PARAGRAPH (a) UNDER SECTION 3.2.12.1 OF ARTICLE 12 OF TAX ORDINANCE NO. 1, OTHERWISE KNOWN AS THE "ORMOC CITY REVENUE CODE OF 1977"

BE IT ORDAINED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Amendment. - Item 12 of paragraph (a) under Section 3.2.12.1 of Article 12 of Tax Ordinance No. 1, otherwise known as the "Ormoc City Revenue Code of 1977", is hereby amended to read as follows:

"12. For the registration of certificate of birth or marriage delayed for a period of one year after birth or marriage ..... P5.00 and for every year of delay thereafter ..... 1.00

SECTION 2. Effectivity. - This Tax Ordinance shall take effect immediately upon its approval.

ENACTED, April 5, 1983.
