"RESOLVED, to adopt:

TAX ORDINANCE NO. 17

AN ORDINANCE TO AMEND SECTION 1.1.1.17 OF TAX ORDINANCE NO. 1,
OTHERWISE KNOWN AS THE "ORMOC CITY REVENUE CODE OF 1977"

BE IT ENACTED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Amendment. - Section 1.1.1.17 of Tax Ordinance No. 1,
otherwise known as the "Ormoc City Revenue Code of 1977", entitled "Exami-
nation of Books of Accounts and Pertinent Records by the City Treasurer"
is hereby amended by adding a new paragraph thereof which shall read as
follows:

"Any violation of the requirements for the production of
books of accounts and pertinent records of business shall be
punishable by a fine of not exceeding one hundred pesos or an
imprisonment of not exceeding thirty days, or both such fine
and imprisonment at the discretion of the court."

SECTION 2. Effectivity. - This Tax Ordinance shall take effect
fifteen days upon its approval.
