

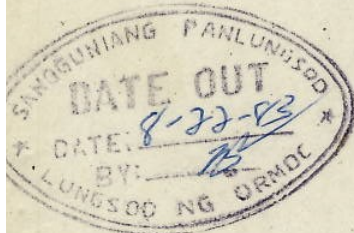

"RESOLVED, to adopt:

TAX ORDINANCE NO. 18

AN ORDINANCE TO AMEND SECTION 4.1.1.7 OF TAX ORDINANCE
NO. 1, OTHERWISE KNOWN AS THE "ORMOC CITY REVENUE
CODE OF 1977"

BE IT ENACTED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Amendment. - Section 4.1.1.7 of Tax Ordinance No. 1,
otherwise known as the "Ormoc City Revenue Code of 1977", entitled
"Rates of Rentals of fixed stalls, booths, and tiendas" is hereby
amended by adding a new item thereunder to be known as Item "d" which
shall read as follows:

"(d) Fix stalls for vegetables and
dried fish section (along
Anilao River) P4.00 daily"

SECTION 2. Effectivity. - This Tax Ordinance shall take effect
fifteen days upon its approval.
