"RESOLVED, to adopt:

TAX ORDINANCE NO. 19

AN ORDINANCE TO AMEND SECTION 4.1.6.3 OF TAX ORDINANCE NO. 1,  
OTHERWISE KNOWN AS THE "ORMOC CITY REVENUE CODE OF 1977"

BE IT ENACTED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Amendment. - Section 4.1.6.3 of Tax Ordinance No. 1,  
otherwise known as the "Ormoc City Revenue Code of 1977" entitled  
"Peddlers on courts, sidewalks, etc." is hereby amended by adding a  
new paragraph thereof which shall read as follows:

"Any violation of these prohibited acts shall be punishable  
by a fine of twenty pesos or an imprisonment of not exceeding five  
days, or both such fine and imprisonment at the discretion of the  
court."

SECTION 2. Effectivity. This Tax Ordinance shall take effect fif-  
teen days upon its approval.
