"RESOLVED, to adopt:

TAX ORDINANCE NO. 20

AN ORDINANCE TO AMEND SECTION 4.1.9.1 OF TAX ORDINANCE NO. 1,
OTHERWISE KNOWN AS THE "ORMOC CITY REVENUE CODE OF 1977"

BE IT ENACTED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Amendment. - Section 4.1.9.1 of Tax Ordinance No. 1,
otherwise known as the "Ormoc City Revenue Code of 1977" is hereby amen-
ded to read as follows:

"SECTION 4.1.9.1. Rates of Payment. - All rates of
payment in connection with services of the Ormoc City
Waterworks System are hereby fixed in the following
manner provided hereunder:

1. Metered rates:

a. Domestic P 1.20/cu.m.
b. Commercial 1.80/cu.m.
c. Special Service (water delivered
to receptacles, boats, barges,
water tanks, etc.) 7.50/cu.m.

2. Flat Rates:

a. Domestic P100.00/month
b. Commercial 200.00/month

3. Minimum:

a. Domestic P 12.00/mo. for 10 cu.m.
b. Commercial 18.00/mo. for 10 cu.m.
c. Special Service 37.50 for 5 cu.m.

4. Deposit:

a. For ½" diam. pipe P100.00
b. For ¾" diam. pipe 150.00
c. For 1" diam. pipe 250.00

5. Installation Fee:

a. For ½" diam. pipe P100.00
b. For ¾" diam. pipe 150.00
c. For 1" diam. pipe 250.00

6. Reopening Fee:

- a. For ½" diam. pipe ₱ 25.00
- b. For ¾" diam. pipe 50.00
- c. For 1" diam. pipe 100.00

SECTION 2. Effectivity. - This Tax Ordinance shall take effect October 1, 1983.

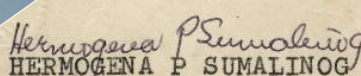

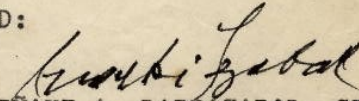

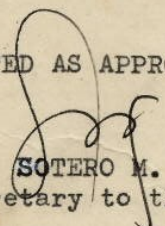
