"RESOLVED, to adopt:

TAX ORDINANCE NO. 21

AN ORDINANCE TO FURTHER AMEND SECTION 4 OF TAX ORDINANCE NO. 7, AS AMENDED BY TAX ORDINANCE NO. 14, OTHERWISE KNOWN AS THE "ORMOC CITY BUS TERMINAL SERVICES ORDINANCE".

BE IT ORDAINED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Further amendment. - Section 4 of Tax Ordinance No. 7, as amended by Tax Ordinance No. 14, otherwise known as the "Ormoc City Bus Terminal Services Ordinance", is hereby amended increasing by fifty per cent (50%) the terminal fees for parking or loading purposes, as follows:

	<u>PER TRIP</u>	<u>OVERNIGHT PARKING</u>
a) Passenger Bus	P10.50	P 18.00
b) Passenger Jeepney	3.00	6.00
c) Private Utility Vehicle	10.50	18.00

SECTION 2. Effectivity. - This Tax Ordinance shall take effect on January 1, 1985.
