TAX ORDINANCE NO. 2

AN ORDINANCE TO AMEND SECTIONS 3.2.1.1, 3.2.4.1 AND 3.2.12.1 OF
ARTICLES 1, 4, AND 12, CHAPTER 2 OF TAX ORDINANCE NO. 22,
AMENDING TAX ORDINANCE NO. 1, OTHERWISE KNOWN AS THE "ORMOC
CITY REVENUE CODE OF 1977" AS AMENDED.

BE IT ORDAINED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Amendment. - Sections 3.2.1.1, 3.2.4.1, and 3.2.12.1
of Articles 1, 4, and 12, under Chapter 2 of Tax Ordinance No. 22, amen-
ding Tax Ordinance No. 1, otherwise known as the 'Ormoc City Revenue
Code of 1977' are hereby amended to read as follows:

CHAPTER 2

Article 1. Marriage License Fee and Solemnization Fee
