## RESOLUTION NO. 126

WHEREAS, the premises of the Shopping Mall at Real, Lopez Jaena and Rizal Streets, this city, have been utilized as parking spaces by private vehicles without paying any fee to the City Government of Ormoc;

WHEREAS, this august Body is in receipt of a recommendation from the City Tresturer to Ohmic to charge parking fees for vehicles which park along the premises of the Shopton Mall;

WARREST to enlance the revenues of the City Government of Ormoc, it is but fair, just and resonable that vehicles which park overnight in these areas be required to say parking fees;

WEREFORE, premises considered, on motion of Kagawad Mariano Y. Corro, Chairman, Cosmittee on Laws and Ordinances, jointly seconded by mga Kagawad Neston C. Penserga and Sotero M. Pepito; be it

RESOLVED, to enact:

## TAX DRDINANCE NO. 93-04

AN ORDINANCE IMPOSING A PARKING FEE ON VEHICLES WHICH PARK OVERNIGHT ALONG THE PREMISES OF THE SHOPPING MALL AT REAL, LOPEZ JAENA AND RIZAL STREETS, THIS CITY, AMENDING THEREBY TAX ORDINANCE NO. 7, SERIES OF 1980, AS AMENDED, OTHERWISE KNOWN AS THE "ORMOC CITY BUS TERMINAL SERVICES ORDINANCE" AND FOR OTHER PURPOSES.

The Sixth Sangguniang Panlungsod ng Ormoc, in a regular session assembled, do hereby ordains, that:

Res. No. 126, Ord. No. 93-04

SECTION 1. New paragraphs are hereby added to at the end of Ordinance No. 7, as amended, which shall read as follows:

"Owner of vehicles which park overnight along the premises of the Shopping Mall at Lopez Jaena, Rizal and Real Streets, this city, shall pay a parking fee of Fifteen (P15.00) Pesos per vehicle per night to be paid to the Office of the City Treasurer of Ormoc before leaving the premises. However, owners of vehicles who are current lessees of the Shopping Mall are exempted from payment of the aforecited parking fee, provided that the vehicles they park overnight are used to transport persons only, and that these vehicles must first be registered in the Office of the Poty Treasurer of Ormoc.

"Passenger vehicles are prohibited from parking along the premises of the Shopping Mall except when authorized by the City Mayor especially when the bus terminal is closed for its use during special occasions. Violators hereof shall be liable for the penalty provided for in Section 9 of Ordinance No. 7, Series of 1980, as amended."

SECTION 2. This amendatory ordinance shall take effect on October 1st, 1993.

SECTION 3. Within ten (10) days after the approval of this Ordinance, copies thereof shall be posted in at least two (2) conspicuous and publicly accessible places.
