PREFATORY STATEMENT

This Ordinance has for its basis Article X, Section 5 of the 1987 itution which grants to each Local Government Unit the power to Constitution which grants to each Local Government Unit the power to create its own sources of revenues and levy taxes, fees and charges subject to such guidelines and limitations as Congress may provide to such guidelines and limitations as Congress may provide the basic policy of Local Autonomy, which taxes, fees shall accrue exclusively to the Local Government Unit, and charges implemented by Section 186 of Republic Act 7160, otherwise known as local Government Code of 1991 as well as Article 274 of the Rules and asyulations implementing said Code, thus, "The Ormoc City Bus Terminal Gervices Ordinance" was enacted by the Second Sangguniang Panlungsod ng Ormoc on April 1, 1980.

Lately, however, it has come to the knowledge of this august Body at the fees imposed under "The Ormoc City Bus Terminal Services rdinance" are no longer applicable at present and that some of its need revisions to conform with the present economic provisions condition, hence, amendment thereto is hereby sought for.

FOREGOING PREMISES, considered, on motion of City Councilor Eduardo P. Tan, Chairman, Committee on Transportation and Communications, seconded by City Councilors Sotero M. Pepito and Fernando P. jointly Parrilla: be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass and enact:

TAX ORDINANCE NO. 2009-001

AN ORDINANCE FURTHER AMENDING SECTION 4 OF TAX ORDINANCE NO. 7 AS AMENDED, OTHERWISE KNOWN AS "THE ORMOC CITY BUS TERMINAL SERVICES ORDINANCE".





Tax Ord. No. 2006-001

BE IT ORDAINED, by the Eighth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Section 4 of said Ordinance is hereby amended to read as follows:

"SECTION 4. TERMINAL FEES. There shall be levied upon and imposed on every passenger bus or jeepney, including vehicles for hire, a terminal fee for services rendered and facilities offered for parking and/or loading purposes categorized as follows:

SECTION 4-A. PARKING FEE. Vehicles plying the route Ormoc-Naniva and Ormoc-Davao shall be allowed to park in the terminal not to exceed five (5) hours from the time of its arrival and in excess thereof a fee of Thirty Pesos (P30.00) shall be collected. For all other routes, one (1) hour free parking is allowed, and in excess thereof, a fee of P20.00 per hour is collected.

SECTION 4-B. USE OF PREMISES. That in no case shall the terminal premises be converted into a garage for vehicles and neither shall major repairs be undertaken thereat.

Bus Terminal No. 1 - Shall be bounded as follows: On the West side, is Real Street, on the East side, Rizal Street, on the South side, is Ebony Street, and on the North side, is Sheinel's Fastfood; this area will be used exclusively for mini bus, jeepneys and multicabs; and

Bus Terminal No. 2 - Shall be bounded as follows: On the West side is Rizal Street and on the East side Bonifacio Street and on the South side is Ebony Street and on the North side is IAL Building and will be used exclusively for buses and other vehicles for hire such as FX, L300, Adventure and the like.

SECTION 4-C. LEASE OF OFFICE SPACES AT BUS TERMINAL. Office Spaces at the Bus Terminal will be leased to qualified occupants on a per square meter basis at the rate of P75.00 per square meter, said contract of lease will be signed by the City Mayor or his duly authorized representative.

SECTION 4-D. The City Administrator is hereby authorized to promulgate the necessary rules and regulations for the proper implementation of this ordinance, which rules and regulations shall be submitted to the Sangguniang Panlungsod ng Ormoc for review and approval within fifteen (15) days from the approval of this ordinance.

SECTION 2. <u>SEPARABILITY CLAUSE</u>. - In case any provision of this Ordinance shall be held or decided invalid or unconstitutional, the validity of the other provisions thereof shall not be affected thereby.

SECTION 3. <u>REPEALING CLAUSE</u>. - Any ordinance, rules and regulations or parts thereof, inconsistent with the provisions of this ordinance are hereby repealed, amended or modified accordingly.

SECTION 4. EFFECTIVITY. This Tax Ordinance shall take effect immediately upon its approval.
