

PREFATORY STATEMENT

Our national leadership urges LGUs to reduce their dependence on the Internal Revenue Allotment (IRA) by searching for sources of funds other than the national government, thereby improving their delivery of basic services.

Considering that Tax Ordinance No. 93-03 has been implemented for almost ten years this august Body finds it necessary to amend Section 79 of said Ordinance quoted hereunder as follows:

SECTION 79 Miscellaneous Fees. The following fees or charges shall be collected:

1. Ten (P10.00) pesos for each tax declaration revised which do not fall under a general revision.
2. One Hundred Pesos (P100.00) annotation fee of mortgaged papers from banks other than Rural Bank of all papers, regardless of the amount of loan granted in the Office of the City Assessor;
3. Twenty-five Pesos (P25.00) annotation fee of mortgaged papers from Rural Banks regardless of the amount in excess of Ten Thousand (P10,000.00) Pesos granted in the Office of the City Assessor;
4. Twenty-five Pesos (P25.00) inspection fee for every individual requesting for inspection of their Real Property/ies in the Office of the City Assessor;

5. Fifteen Pesos (P15.00) for every cancellation of any mortgage of Real Property/ies in the Office of the City Assessor;
6. Five Pesos (P5.00) for a certified xerox copy per sheet of assessment paper of the Real Property/ies in the Office of the City Assessor;
7. Five Pesos (P5.00) certification fee for any paper or document issued by the Office of the City Assessor.

WHEREFORE, foregoing premises considered, on motion of City Councilor Demosthenes F. Tugonon, Chairman, Committee on Ways and Means, jointly seconded by City Councilors Ruviniu E. Mendola & Rafael C. Omega, Jr.; be it

RESOLVED, to adopt:

TAX ORDINANCE NO. 2002-002

AN ORDINANCE AMENDING SECTION 79 MISCELLANEOUS FEES OF TAX ORDINANCE NO. 93-03 ON REAL PROPERTY TAXATION IN ORmoc CITY.

BE IT ORDAINED, BY THE NINTH SANGCUNIANG PANLUNGSOD NG ORmoc, That:

SECTION 1. Sec. 79 of Ordinance No. 93-03 shall now read as follows:

(A) Miscellaneous Fees. The Following Fees or charges shall be collected:

1. Thirty Pesos (P30.00) Revision Fee for every request for revision of Tax Declaration (TD) which does not fall under a general revision every 3 years.
2. One Hundred Twenty Pesos (P120.00) annotation fee of mortgaged papers from banks other than Rural Bank of all papers, regardless of the amount of loan granted in the Office of the City Assessor.
3. Fifty Pesos (P50.00) annotation fee of mortgaged papers from Rural Banks regardless of the amount in excess of Ten Thousand (P10,000.00) pesos granted in the Office of the City Assessor.
4. Fifty Pesos (P50.00) inspection fee for every request for ocular inspection of real property.
5. Twenty Pesos (P20.00) for every cancellation of any mortgage of Real Properties in the Office of the City Assessor.
6. Ten Pesos (P10.00) for every certified true copy of Tax Declaration (TD) and other related real property assessment documents.
7. Ten Pesos (P10.00) per page Certification Fee for every certification re: landholdings/encumbrances/no property and other related real property assessment documents issued.

(B)

8. Five Pesos (P5.00) Research/Verification Fee for property for every research/verification made on real property assessment record.

SECTION 2. SEPARABILITY CLAUSE. If for any person any provision hereof is declared unconstitutional or invalid, other parts or provisions which are not affected thereby shall continue to be in full force and effect.

SECTION 3. REPEALING CLAUSE. All ordinances or provisions of ordinances which are inconsistent with this Ordinance are considered repealed or modified accordingly.

SECTION 4. EFFECTIVITY. This Ordinance shall take effect immediately after its publication once in a local newspaper of general circulation within the City of Ormoc..

SECTION 5. PUBLICATION. In order to comply with the requirements of Republic Act 7160, otherwise known as the Local Government Code of 1991, specifically Section 188 thereof, within ten (10) days after the approval of this Ordinance, a copy hereof shall be posted in at least two (2) conspicuous places of the City and published once a week in a newspaper of General Circulation in Ormoc City.
