Ormoc, a city which used to have four to five cinema house operating in

WHEREAS, one of the reasons alleged to have cause in the decline of the civema industry in this City, is the imposition of the "20% amusement tax of grass receipts from admission fees", which is claimed by operators to be excessive;

WHIREAS in order to encourage the operation of cinema houses and other places of amusement in Ormoc City, the reduction of the present rate of amusement tax is appropriate;

WHEREAS, the required public hearing for the passage of tax Ormoc Session Hall.

TAX ORDINANCE NO. 2005-001

AN ORDINANCE AMENDING SECTION 2 OF TAX ORDINANCE NO. 2001-002, ENTITLED: "AN ORDINANCE REVISING THE RATES OF AMUSEMENT TAX IN THE CITY OF ORMOC".

BE IT ORDAINED, by the Tenth Sangguniang Panlungsod ng Ormoc, in Regular Session, assembled, that:

SECTION 1. That Section 2 of Tax Ordinance No. 2001-002, entitled: "AN ORDINANCE REVISING THE RATES OF AMUSEMENT TAX IN THE CITY OF is hereby amended, to now read as follows:

"SECTION 2. There shall be levied and collected from the proprietors, lessees, operators of theaters, cinemas, concert halls, circuses, boxing stadia, and other places of amusement, an <u>AMUSEMENT TAX OF TEN PERCENT (10%)</u> of the gross receipts from admission fees; Provided, that in case the amusement tax due and payable is paid within ten (10) days after the end of the month for which it is applicable, a discount of five percent (5%) of tax due shall be given to the taxpayer.

SECTION 2. That all the other provisions of the aforementioned Ordinance No. 2001-002, are hereby adopted in its entirety, EXCEPT Effectivity Clause, provided in Section 10 thereof: ementioned Yax

SECTION 3. This Amendatory Ordinance shall take effect on October 1, 2005, after it shall have been published once in a newspaper of general circulation in Ormoc City, and posted in at least two (2) general circulation in Ormoc City, and posted i conspicuous and publicly accessible places in Ormo least two (2)
