PREFATORY STATEMENT

WHEREAS, the 15th Sangguniang Panlungsod ng Ormoc was in receipt of an endorsement from the Office of the City Mayor dated July 7, 2021 requesting for amendment of Ordinance No. 168 otherwise known as an "Ordinance Revising and Updating the City Civil Registry Fees and Charges" to empower the Local Civil Registrar to charge service fees for the Batch Request System (BREQS) of the Philippine Statistics Authority (PSA);

WHEREAS, the PSA is currently implementing the Civil Registry System IT(CRS-IT2) Project which has already establish on-line Census Serbilis Centers (Serbilis Outlets) in various locations of the Philippines to serve as service points for the decentralized servicing of requests for civil registry documents from the public;

WHEREAS, the Local Government Unit of Ormoc City, through the Office of the Civil Registrar, receives and serves requests for civil registry documents registered in the City and plans to provide a more extensive service to those that may have been registered in other localities;

WHEREAS, the PSA has developed the BATCH REQUEST QUERY SYSTEM (BREQS) - First Party System, a system for the use of the City which provides for an off-line method of encoding request for civil registry documents and submission thereof to an on-line Serbilis Outlet of the PSA;

WHEREAS, in order to properly implement and cover the cost of processing the civil registry documents, there is a need to impose and collect service fees thereof;

WHEREAS, a public hearing was conducted last September 24, 2021 in compliance of the legal requirement provided for in the Local Government Code;

WHEREFORE, on motion of SP Member Tomas R. Serafica, Chairman, Committee on Ways & Means, severally seconded by SP Members Gregorio G. Yrastorza III, Lalaine A. Marcos, Esteban V. Laurente, Joan Marbie C. Simbajon and Jasper M. Lucero; be it

SECTION 3. REPEALING CLAUSE – All Ordinances and/or Resolutions, or portions thereof, inconsistent with this Ordinance are hereby repealed or modified accordingly.

SECTION 4. SEPARABILITY CLAUSE – If for any reason any provision of this Ordinance is declared unconstitutional or invalid by any competent court, the other parts or provisions hereof which are not affected thereby shall continue in full force and effect.

SECTION 5. EFFECTIVITY - This Ordinance shall take effect immediately upon approval and after compliance with necessary posting and publication requirements of Republic Act No. 7160, otherwise known as the Local Government Code of 1991.
