PREPATORY STATEMENT

In response to ease the flow of traffic in the City of Ormoc and for public safety purposes, the Sangguniang Panlungsod ng Ormoc passed Ordinance No. 112 dated May 27, 2004 entitled: "AN ORDINANCE ADDING CHAPTER VIII OF TITLE ELEVEN (TRAFFIC REGULATION) OF ORDINANCE NO. 2003-130A, ENTITLED: "AN ORDINANCE ORDAINING THE CODIFICATION OF THE GENERAL ORDINANCES OF THE CITY OF ORMOC" DECLARING AS ONE-WAY TRAFFIC, (1) SAN PEDRO STREET FROM THE CORNER OF OSMEÑA STREET TO THE CORNER OF SAN PEDRO AND CARLOS TAN STREETS; (2) CARLOS TAN STREET FROM THE CORNER OF SAN PEDRO AND CARLOS TAN STREETS TO ARRADAZA STREET; AND (3) ARRADAZA STREET FROM THE CORNER OF ARRADAZA AND CARLOS TAN STREETS TO THE CORNER OF ARRADAZA STREET AND OSMEÑA STREET DURING SCHOOL DAYS (MONDAY TO FRIDAY) FROM 6:00 A.M. TO 5:30 P.M. and Ordinance No. 113 dated May 27, 2004 entitled: "AN ORDINANCE ADDING CHAPTER VII OF TITLE ELEVEN (TRAFFIC REGULATION) OF ORDINANCE NO. 2003-130A, ENTITLED: "AN ORDINANCE ORDAINING THE CODIFICATION OF THE GENERAL ORDINANCES OF THE CITY OF ORMOC" DECLARING AS ONE-WAY TRAFFIC, (1) JOSE NAVARRO STREET FROM THE CORNER OF OSMEÑA STREET TO CARLOS TAN STREET; (2) FROM THE CORNER OF JOSE NAVARRO STREET AND CARLOS TAN STREETS TO CORNER CARLOS TAN AND ARRADAZA STREETS; AND (3) FROM THE CORNER OF CARLOS TAN AND ARRADAZA STREETS TO OSMEÑA STREET THIS CITY, DURING SCHOOL DAYS (MONDAY TO FRIDAY) FROM 6:00 A.M. TO 5:30 P.M.";

Lately, however, this august Body is in receipt of Barangay Resolution No. 3, S. 2007 from the Barangay Council of Barangay District 10, this city entitled: "RESOLUTION EARNESTLY URGING THE 9TH SANGGUNIANG PANLUNGSOD, THIS CITY, TO AMEND CITY ORDINANCE NO. 112 AND 113 SERIES OF 2004 BY DECLARING SAN PEDRO STREET FROM THE CORNER OF SAN PEDRO AND OSMEÑA STREETS TO THE CORNER OF SAN PEDRO AND CARLOS TAN STREETS AND DECLARING JOSE NAVARRO STREET FROM THE CORNER OF OSMEÑA AND JOSE NAVARRO STREETS TO THE CORNER OF JOSE NAVARRO AND CARLOS TAN STREETS, AS TWO-WAY TRAFFIC";

It has also been observed by this Sanggunian that some portions of the aforementioned streets become traffic problems and traffic bottleneck thereby defeating the purpose for which it was intended, hence a total repeal of the aforementioned City Ordinances is recommended;

RESOLVED, to adopt:

ORDINANCE NO. 132

AN ORDINANCE AMENDING SECTION 1 OF BOTH ORDINANCES NO. 112 AND 113 BY MAKING SAN PEDRO STREET FROM THE CORNER OF OSMEÑA AND CARLOS TAN STREETS, ARRADAZA STREET FROM CORNER OF OSMEÑA TO CARLOS TAN STREET, AND NAVARRO STREET FROM THE CORNER OF OSMEÑA AND CARLOS TAN STREETS AS TWO-WAY TRAFFIC, THEREBY MAINTAINING CARLOS TAN FROM THE CORNER OF SAN PEDRO TO JOSE NAVARRO STREETS AS ONE-WAY TRAFFIC DURING SCHOOL DAYS (MONDAY TO FRIDAY FROM 6:00 AM TO 5:30 PM).

BE IT ORDAINED, by the 10th Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. ORDINANCE NO. 112 entitled: "AN ORDINANCE ADDING CHAPTER VIII OF TITLE ELEVEN (TRAFFIC REGULATION) OF ORDINANCE NO. 2003-130A, ENTITLED: "AN ORDINANCE ORDAINING THE CODIFICATION OF THE GENERAL ORDINANCES OF THE CITY OF ORMOC" DECLARING AS ONE-WAY TRAFFIC, (1) SAN PEDRO STREET FROM THE CORNER OF OSMEÑA STREET TO THE CORNER OF SAN PEDRO AND CARLOS TAN STREETS; (2) CARLOS TAN STREET FROM THE CORNER OF SAN PEDRO AND CARLOS TAN STREETS TO ARRADAZA STREET; AND (3) ARRADAZA STREET FROM THE CORNER OF ARRADAZA AND CARLOS TAN STREETS TO THE CORNER OF ARRADAZA STREET AND OSMEÑA STREET DURING SCHOOL DAYS (MONDAY TO FRIDAY) FROM 6:00 A.M. TO 5:30 P.M. and ORDINANCE NO. 113 entitled: "AN ORDINANCE ADDING CHAPTER VII OF TITLE ELEVEN (TRAFFIC REGULATION) OF ORDINANCE NO. 2003-130A, ENTITLED: "AN ORDINANCE ORDAINING THE CODIFICATION OF THE GENERAL ORDINANCES OF THE CITY OF ORMOC" DECLARING AS ONE-WAY TRAFFIC, (1) JOSE NAVARRO STREET FROM THE CORNER OF OSMEÑA STREET TO CARLOS TAN STREET; (2) FROM THE CORNER OF JOSE NAVARRO STREET AND CARLOS TAN STREETS TO CORNER CARLOS TAN AND ARRADAZA STREETS; AND (3) FROM THE CORNER OF CARLOS TAN AND ARRADAZA STREETS TO OSMEÑA STREET THIS CITY, DURING SCHOOL DAYS (MONDAY TO FRIDAY) FROM 6:00 A.M. TO 5:30 P.M. are hereby amended by making San Pedro Street from the corner of Osmeña Street and Carlos Tan Street, Arradaza Street from corner of Osmeña Street to Carlos Tan Street, and Jose Navarro Street from the corner of Osmeña and Carlos Tan Street as two-way traffic, thereby maintaining Carlos Tan Street from the corner of San Pedro to Jose Navarro Streets as one-way traffic during school days (Monday to Friday from 6:00 am. to 5:30 pm.).

SECTION 2. This Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, to direct the Chief of Police of Ormoc City to coordinate with the City Engineer in putting the necessary traffic signs in said streets for purposes of this ordinance.

RESOLVED, FURTHERMORE, to furnish copies of this Ordinance each to His Honor, the City Mayor, the City Administrator, the City Legal Officer, the City Police Director, the Precinct Commander, PP1, the DILG-CGO Officer, the Barangay Chairman, District 10, the Regional Trial Court, Municipal Trial Court and others concerned, -in Ormoc City;


