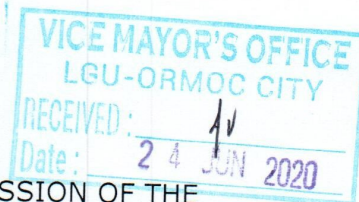

PREFATORY STATEMENT

WHEREAS, this Sanggunian was in receipt of an endorsement dated January 07, 2020 from the Office of the City Mayor regarding the proposal to amend Section 2, Rates of Fees under Article VI of Ordinance No. 104, otherwise known as the "Slaughterhouse Code of Ormoc City";

WHEREAS, to recall, Ormoc City Ordinance No. 104 was enacted by this Sanggunian in July 28, 2003 to govern the management, operations and administration of the Metro Ormoc Slaughterhouse located in Barangay Macabug, this City;

WHEREAS, since 2003 until the present, rates of fees of the Metro Ormoc Slaughterhouse had never been increased - nearing 17 years already;

WHEREAS, the City Mayor's Office received an endorsement letter dated December 9, 2019 from the designated Acting City Government Department Head of the Slaughterhouse, Dr. Jose Arnil C. Corong, endorsing the proposal to amend Section 2, Rates of Fees under Article VI of Ordinance No. 104 and attaching therein the proposed new rates;

WHEREAS, the City Legal Office issued an opinion dated January 3, 2020 stating that due consideration of said proposal falls with the purview of the Sangguniang Panlungsod ng Ormoc and that after review of the documents, it finds no impediment to said increase, thus, recommends that the proposal be endorsed to this Sanggunian for deliberation and appropriate action;

WHEREAS, foregoing premises considered, this Sanggunian finds great merit of the City Mayor's request amendment to increase the rates of fees of the Metro Ormoc Slaughterhouse intended for the benefit of the City as well as have a significant impact on the efficiency of management, administration, maintenance sanitation and viable operation of said Slaughterhouse;

ORDINANCE NO. 029
(Series 2020)

AN ORDINANCE AMENDING SECTION 2, ARTICLE VI OF
ORDINANCE NO. 104, OTHERWISE KNOWN AS "THE
SLAUGHTERHOUSE CODE OF ORMOC CITY".

Be it ordained by the Sangguniang Panlungsod of Ormoc City, Leyte that:

SECTION 1. AMENDMENT – Section 2 of Article VI of Ordinance No. 104 is hereby amended to read as follows:

"Section 2. Rates of Fees – The rates of fees shall be as follows:

SECTION 2. REPEALING CLAUSE - All Ordinances and or Resolutions, or portions thereof, inconsistent with this Ordinance are hereby repealed or modified accordingly.

SECTION 3. SEPARABILITY CLAUSE - If for any reason any provision of this Ordinance is declared unconstitutional or invalid by any competent court, the other parts or provisions hereof which are not affected thereby shall continue in full force and effect.




