WHEREAS, per Resolution No. 95-18 the Chairman of the Committee on Youth and Sports Development is Honorable Angelyn R. Paca, the President of the Federasyon ng mga Sangguniang Kabataan of Ormoc City;

WHEREAS, the term of office of Hon. Angelyn R. Paca expired on May 31, 1996;

WHEREAS, the newly elected President of the Federasyon ng mga Sangguniang Kabataan of Ormoc City is Honorable Chiqui Labagala of Brgy. Dist. VIII, this city;

WHEREAS, Section 438, par. (c) of the Local Government Code of 1991 (RA 7160) provides:

"The pederasyon president or vice president, as the case may be, shall be the chairman of the committee on youth and sports development of the sanggunian concerned."
