ROCΑ. BRESILA LANTAYONA, IMPLEMENTATION OF THE GRASSROOTS PARTICIPATORY BUDGETING PROJECTS IN THE AMOUNT OF THREE MILLION SEVEN HUNDRED SIXTY THOUSAND PHILIPPINE PESOS (P3,760,000.00) SIGNIFYING APPROVAL OF THE PROJECTS AND ACCEPTANCE OF THE TERMS AND CONDITIONS THEREBY AMENDING SP RESOLUTION NO. 2014-117 DATED JULY 10, 2014.

Lantayona instead of Regional Director Cynthia Nierras since the approval of the BuB Projects subject of the MOA will be done at the national level;

WHEREAS, this august Body finds that the proposed amendments are indeed necessary to carry out the purpose and objectives of the MOA on the implementation of Grassroots Participatory Budgeting Projects in Ormoc City, hence, the need to pass this resolution to incorporate all the required amendments to said Resolution No. 2014-117 dated July 10, 2014;

Penserga and Vincent L. Rama; be it
